**ORDINANCE NO. 4.334**

**AN ORDINANCE CALLING A GENERAL ELECTION FOR THE ELECTION OF ONE POSITION TO THE GLADSTONE CITY COUNCIL ON TUESDAY, APRIL 5, 2016; DESCRIBING THE FORM OF THE BALLOT AND DIRECTING THE CITY CLERK TO SUBMIT CERTIFICATION OF SUCH ELECTION TO THE CLAY COUNTY BOARD OF ELECTION COMMISSIONERS PURSUANT TO RSMo 115.125.**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:**
