A RESOLUTION AUTHORIZING ACCEPTANCE OF A PROPOSAL FROM FOLEY EQUIPMENT FOR THE PURCHASE OF A SKID STEER TRACK LOADER AND A BACKHOE IN THE COMBINED PURCHASE AMOUNT OF \$173,583.00.

WHEREAS, the City of Gladstone is a member of the National Joint Powers Alliance (NJPA);
and

WHEREAS, NJPA requests and accepts proposals for specialty equipment on a National level;
and

WHEREAS, staff reviewed the NJPA contracts for the purchase of a Skid Steer Track Loader and a Backhoe; and

WHEREAS, the Department of Public Works recommends the acceptance of the NJPA contract proposals from Foley Equipment for the purchase of a Skid Steer Track Loader and a Backhoe in the combined purchase amount of \$173,583.00.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI AS FOLLOWS:

THAT, the City Manager of the City of Gladstone, Missouri, be and is hereby authorized to accept the proposals of Foley Equipment in the combined purchase amount of \$173,583.00.

FURTHER, funds for such purpose are authorized from the General Fund and the CWSS Fund.

RE: FY-15 Skid Steer Track Loader and Backhoe Purchase

Municipalities often use joint bids when purchasing specialty equipment. After reviewing the different options, the National Joint Powers Alliance (NJPA) appears to be the City's best option. The City is a member of the NJPA and staff has used this program in the past for City purchases.

After reviewing the NJPA contracts for heavy equipment, it is the recommendation of the Department of Public Works to accept the bids of Foley Equipment for the purchase of a Backhoe and Skid Steer Track Loader.
