Flora Park East Spillway Modifications

Staff received the following bids for the referenced project, including Bid Alternate 1:

Linaweaver Construction Inc.	\$52,310.00
SheDigs It LLC	\$55,105.00
Gunter Construction Company	\$71,038.00
Four J. Environmental, LLC	\$75,297.60

The Engineer's estimate, prepared by staff, was \$80,812.50.

This project involves the modification of an existing detention basin spillway including 230 cubic yards of excavation, 500 cubic yards of embankment, 560 square yards of turf reinforcement mat, and related work. The project will remove approximately 6 homes from the floodplain along Mill Creek.

Linaweaver Construction is a company based in Lansing, KS that has been in business for a total of 31 years. Linaweaver Construction has completed several projects for the City over the past few years. Staff is very pleased with their work and is looking forward to working with them again on this project.
