
WHEREAS, eight proposals were received for the 2016 Water Main Replacement Project WP1786, and the proposal of Hettinger Excavating LLC in the amount of \$581,269.00 has been determined by the Director of Public Works and City Engineer to be the lowest and best proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:


THAT, the City Manager of the City of Gladstone, Missouri, is hereby authorized to execute a contract with Hettinger Excavating LLC for work as outlined in the contract for a total amount not to exceed \$581,269.00.

FURTHER, THAT funds for such purpose are authorized from the Combined Waterworks and Sewerage System Funds Budget.

Staff received the following bids for the referenced project, including Bid Alternates 1 & 2:

Hettinger Excavating, LLC	\$581,269.00	Linaweaver Construction Inc.	\$725,410.00
VF Anderson Builders LLC	\$593,401.00	SheDigs It LLC	\$726,986.00
Blue Nile Contractors, Inc.	\$606,063.33	Redford Construction, Inc.	\$786,095.00
Westland Construction	\$665,303.00	Pyramid Excavation & Const.	\$810,105.00

The Engineer's estimate, prepared by staff, was \$788,790.00.

This project involves the installation of 3,100 LF of 8" water main, 188 LF of 6" water main, fire hydrants, valves, fittings, and related appurtenances as recommended in the 2015 Water Distribution System Master Plan. Water mains scheduled for replacement include:

- N. Wayne/NE 60th Terrace from N. Michigan to NE 61st Terrace
- N. Woodland from NE 60th Terrace to NE 61st Street
- N. Walnut from NE 72nd Street to NE 72nd Terrace
- N. Michigan from NE 60th Terrace to NE 62nd Terrace

Hettinger Excavating, LLC is based in Drexel, MO and has been in business for a total of 12 years. Hettinger Excavating completed the 2013 Small Water Main Replacement Project. Staff was very pleased with their work and is looking forward to working with them again on this project.

Based on all available information, staff is recommending that this project be awarded to Hettinger Excavating, LLC at the bid price of \$581,269.00, including Bid Alternates 1 and 2 at the next regularly scheduled City Council meeting. Funds are provided from the CWSS Fund.
