 - a. Manor Drive NE Englewood Road to N. Tracy
 - b. NE 56th Terrace N. Brooklyn to N. Pursell Road
 - c. N. Belleview NW 44th Terrace to N. Briarcliff Lane
 - d. NE 60th Terrace N. Broadway to N. Wyandotte
 - e. NE 72nd Terrace N. Flora to N. Forest
- 3. NE 71st Street and N. Locust Street Improvements \$250,000
- 4. N. Campbell Sidewalk \$225,000
 - a. NE 70th Terrace to NE 72nd Street

Commissioner Michael Sosa stated he preferred Item #2, more "bang for your buck", more roads for the same amount of money.

Chairman John Houlihan and Clerk Eugene Suter stated they preferred Item #4. It was discussed to complete Item #4 and use the balance of the funds for Item #2.

Chairman John Houlihan moved to distribute Road District funds towards Item #4, and upon completion, the remaining funds to be placed towards Item #2. Clerk Eugene Suter seconded. The vote: "aye" – Chairman John Houlihan and Clerk Eugene Suter. "Nay" – Commissioner Michael Sosa. (2-1).
