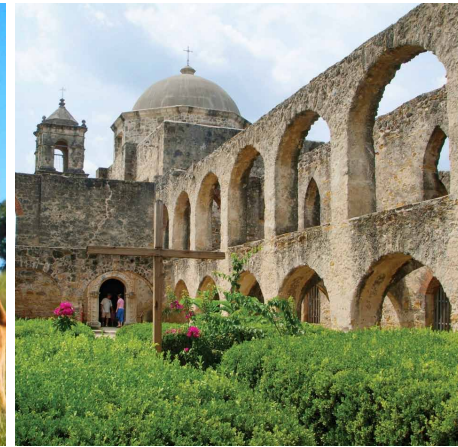
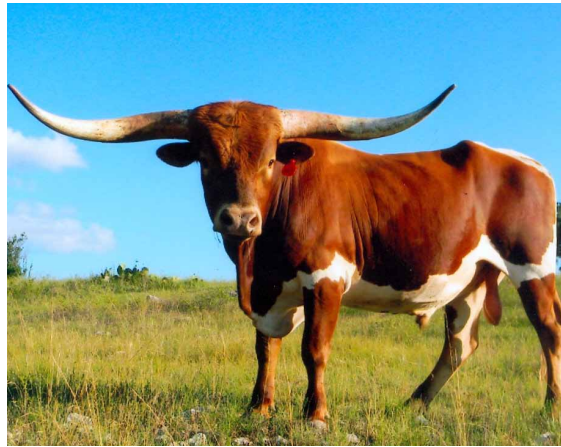

## Texas Triangle Itinerary

### Day 1: Dallas

Fly to **Dallas** where upon arrival you will be met by your **Tour Director** and transfer to your hotel. Tonight enjoy a **Welcome Dinner** with your fellow travelers.

### Day 2: Dallas - Fort Worth Sightseeing

Today enjoy a **Dallas City Tour** featuring Fair-Park, JFK Memorial, World Trade Center and Dealy Plaza Downtown Dallas. Visit the **Sixth Floor Museum at Dealy Plaza**, which contains a historical exhibition dealing with the life, times, death and legacy of John F. Kennedy with a focus on the impact of his death on the nation and the world. Later visit the **Fort Worth Stockyards National Historic District**, an important livestock center constructed in 1887 after the railroad arrived in Fort Worth. Tonight enjoy dinner at **Billy Bob's Texas**, a former cattle barn now called "The World's Largest Honky Tonk".

### Day 3: Dallas - Houston

This morning visit the new **George W. Bush Presidential Library & Museum** near the SMU Campus. The library museum tells the story of an extraordinary time in our nation's history and features exhibits and artifacts related to his Presidency including a full-sized Oval Office. Later travel south to **Houston** for a two-night stay in the 4th largest city in the US.

### Day 4: Houston Sightseeing

Today enjoy a **Houston City Tour** featuring Rice University, Williams Tower, Reliant Stadium and the Old South Ward to view some beautiful Victorian homes. Later visit and tour the **Johnson Space Center**, home to the US astronaut corps and responsible for training astronauts from both the US and our international partners. The center is often popularly referred to by its central function during missions, Mission Control.

*Meal - (B) Overnight: Houston*

### Day 5: Houston - Austin - San Antonio

This morning travel to the beautiful capital of Texas for an **Austin City Tour** to see the Governors Mansion, the University of Texas and the State Capitol. Then visit the **Bullock Texas State History Museum** to learn the continually unfolding "Story of Texas." Later journey south to **San Antonio** and check-in to your hotel for a three-night stay. The city's old-Spanish flavor, multi-cultural heritage and the **Riverwalk**

make it one of America's more intriguing cities. The Riverwalk (Paseo Del Rio) is a fabulous loop off the San Antonio River offering tree-lined footpaths, shopping, galleries and restaurants.

### Day 6: San Antonio Sightseeing

Today enjoy a **San Antonio City Tour** featuring many highlights of this great city. Visit the **San Jose Mission** where you will view the famous Rose Window. Later wander through the colorful **El Mercado Marketplace**. Later go to the **IMAX Theatre** to see the docudrama "The Price of Freedom" which recounts the battle of the Alamo. Then visit the Shrine of Liberty, the **Alamo** to see the chapel, one of the most photographed sites in the nation, and wander through this historic landmark. Complete your day with a leisurely **Riverwalk Cruise** and learn more about the history of this San Antonio highlight.

### Day 7: San Antonio - Hill Country - San Antonio

Today journey into the **Hill Country of Texas**. The first stop will be in Stonewall where you will board a tram for a tour of the **LBJ Ranch**, the former home of the 36th President, Lyndon Baines Johnson. The tour includes a reconstruction of the farmhouse where LBJ was born and his ranch house, referred to as the "Texas White House." Next visit the German settlement of **Fredericksburg** which retains touches of Old World Heritage. Tonight enjoy your **Farewell Dinner** at a popular local restaurant on the Riverwalk.
