Item No. 1. On the Agenda. Meeting Called to Order.

Mayor Garnos opened the Regular City Council Meeting Monday, March 13, 2023, at 7:30 pm.

Item No. 2. On the Agenda. Roll Call.

Mayor Garnos stated that all Councilmembers were present and there was a quorum.

Mayor Garnos asked all to join in the Pledge of Allegiance to the Flag of the United States of America. Boy Scout Troop #260 led the group in the Pledge of Allegiance.

<u>Item No. 7. On the Agenda.</u> PROCLAMATION: Justin Merkey, Parks, Recreation, and Cultural Arts Director, accepted the 2023 Arbor Day Proclamation from Mayor Garnos. Director Merkey announced that the City would celebrate Arbor Day on Friday, April 7th at Meadowbrook Park. The Mayor also noted that the City of Gladstone has been recognized as a Tree City USA for the 21st year.

Larry Newport, 1008 NE 75th Street, addressed the City Council. Mr. Newport inquired about installation of a street light on the Northwest corner of NE 75th Street and N. Troost. He said the corner is very dark at night.

Item No. 9 On the Agenda. Communications from City Council.

Councilman Smith took a moment to recognize the tragedy of Jayden Robker and also offered his thanks to the Gladstone Police Department for their role in this difficult investigation.

Councilman Smith said he attended Fire Chief Sean Daugherty's retirement ceremony yesterday. He again wanted to extend his thanks to Sean for his years of service.

Lastly, Councilman Smith commented that there was a water main break in his neighborhood today and was thankful for the Public Works crews that were so timely in their response. He asked Director Nebergall to pass that along to the crews.

Councilman Mallams said he had an opportunity to go to the MILO training that Gladstone Police Officers attended. It is a very serious computer simulated scenario where officers must think quickly and respond with a Taser in place of a handgun. He commented on what a valuable training opportunity it is for the Officers. He thanked Chief Farris for bringing this training to Gladstone again.

Mayor Pro Tem Moore said that she wanted to extend her thanks for the MILO training as well. She was also able to attend the training and learned a lot. Mayor Pro Tem Moore said she now has an even higher degree of respect for how officers have to make decisions in a split second.

Mayor Pro Tem Moore added her note of appreciation to Fire Chief Sean Daugherty for his 25 years of service to this City. Yesterday's event was a very meaningful celebration.

She gave recognition to the Parks and Public Works crews for their efforts in picking up trash last week.

Linden Square was recently awarded the Great Public Space Award. Mayor Pro Tem Moore said this is a really great tribute to the space and everything that takes place at the venue.

Mayor Garnos announced the City Council Candidate Forum coming up on Thursday, March 23rd at the Community Center from 6:30-8:00 pm. The Forum will be moderated by students of the Oak Park High School government club and is also being sponsored by the Gladstone Chamber of Commerce and Northland Neighborhoods, Incorporated. WHEREAS, the City Council believes it is in the best intent of the Community to adjust residency requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

THAT, Section 1.105.340 Residency Requirements be deleted in its entirety and replaced with a new Section 1.105.340 Residency and qualification for office requirements.

Section 1.105.340- Residency and qualifications for office requirements.

All officers elected or appointed to offices under the city government shall be qualified voters under the laws and constitution of this state. City councilmembers elected to office or appointed to fill a vacancy in a city councilmember office, the city manager, and the municipal judges shall be residents of the city, or with respect to the city manager and municipal judges, shall establish residency within a reasonable time after appointment. No person shall be elected or appointed to any office who shall at the time be in arrears for any unpaid city taxes, or forfeiture or defalcation in office.
