Mayor Spallo opened the Regular City Council Meeting Monday, July 8, 2024, at 7:30 pm.

Item No. 2. On the Agenda. Roll Call.

Mayor Spallo stated that all Councilmembers were present and there was a quorum.

Item No. 3. On the Agenda. Pledge of Allegiance to the Flag of the United States of America.

Mayor Spallo asked all to stand and join in the Pledge of Allegiance to the Flag of the United States of America.

Item No. 4. On the Agenda. Approval of the Agenda.

The agenda was approved as published.

Item No. 5. On the Agenda. Approval of the June 24, 2024, Closed City Council Meeting Minutes.

Councilmember Moore moved to approve the minutes of the June 24, 2024, Regular City Council meeting as presented. Mayor Pro Tem Smith seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0)

**Councilmember Moore** reported that she joined fellow Clay County residents on July 4, 2024 at the AJ Farm for a meaningful reading of the Declaration of Independence and Constitution. She expressed her gratitude to the Parks, Recreation, and Cultural Arts, Fire, and Police departments for a successful July 4<sup>th</sup> evening celebration at Oak Grove Park. She gave a special thanks to Councilman Garnos and his wife for participating in the clean-up efforts with the Glad Green Team and expressed her appreciation for all who joined and encouraged others to continue to work together to improve our community's appearance. Lastly, she requested a moment to honor the memory and service of former Councilman Dave Fricke who recently passed away.

**Mayor Pro Tem Smith** expressed his appreciation to everyone involved in the 4<sup>th</sup> of July event. He shared that he was grateful for the kind words spoken by Councilmember Moore about Dave Fricke, a dear friend of his, who would be missed.

**Mayor Spallo** reported that she recently attended the dedication of the new public art piece, Monarch Girl, at Oak Grove Park. She shared that the artwork is located at N. Troost and NE 76<sup>th</sup> Street and features a monarch butterfly on one side and a little girl jumping on the other side. She encouraged everyone to take a moment to view the beautiful art work. She also congratulated Mayor Pro Tem Smith on becoming a new grandfather.

Councilmember Moore moved to approve the Special Event Permits:

**Councilman Davis** seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0)

Councilmember Moore moved to approve RESOLUTION R-24-39, A Resolution authorizing Change Order No. 4 in the amount of \$96,025.75 to the contract with Infrastructure-Solutions, LLC, for the FY24 Water Main Replacements and Storm Drainage Project WP2487. Councilman Davis

seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0)

#### REGULAR AGENDA.

<u>Item No. 11. On the Agenda.</u> CONTINUED PUBLIC HEARING: Site Plan Revision for property at 7200 North Broadway.

**Mayor Spallo** re-opened the Public Hearing from June 10, 2024 at 7:38 pm for the Site Plan Revision for property at 7200 North Broadway. She announced the applicant would be heard regarding information requested about fuel truck ingress and egress by the City Council and then individuals in favor and those opposed to the new information.

Mr. Gerald Menefee reported the movement of the trucks at the site had been reviewed, but first addressed the tree line in the winter and proposed moving the retaining wall out and placing a line of pine trees to shield the buildings in the winter time. He then discussed the ingress and egress of the fuel trucks. He shared two (2) drawings showing each way entering and leaving the site and reported that the trucks could not turn around inside the site, so it would have to enter in one driveway and exit the other driveway. The first drawing showed the entry of the truck entering in off northbound N. Broadway, making a left turn onto the property, going around passed the pumps to the fuel storage area on the south end of the site, and then the trucks would exit onto NW 72<sup>nd</sup> Street. The second option would be entering from NW 72<sup>nd</sup> Street which would be a large swing area into the driveway, but reported that coming out to go south bound on N. Broadway could create an issue, because the truck would have to go into the middle of the road in order to regain a southbound orientation.

F. J. Cronenwett, stated that he was from a company that supplies fuel locally. He explained the approximate frequency of deliveries and different scenarios, reporting that in most cases drivers deliver as early as possible. He described sizes of the various delivery vehicles and stated the transportation companies would ensure the transport vehicle has the capacity to get in and out of that location. He also commented that the drivers will know the easiest way to enter and exit. He gave a positive character witness regarding the owner and stated his other stores are well maintained. He reported that there typically aren't any vapor smells from the tanks during the delivery process.

There were no audience members that came forward in favor of the application.

Vicky Marshall, 401 NE 72<sup>nd</sup> Terrace, expressed her opposition due to the potential smells and decrease in value of her home due to the presence of a gas station.

Jinny Kyle, 7006 N. Walnut Street, expressed her opposition due to the potential of the gasoline trucks cutting through her neighborhood. She expressed her concerns about alcohol being sold since there are other existing stores selling it which are in close proximity to the applicant's location. She voiced her concern regarding the potential increase of trash and litter accumulation caused by patrons.

Mayor Spallo closed the Public Hearing at 7:52 pm.

<u>Item No. 12. On the Agenda.</u> FIRST READING BILL NO. 24-21, An Ordinance approving a Site Plan Revision for property at 7200 North Broadway.

Councilman Davis moved BILL NO. 24-21 be placed on its First Reading. Mayor Pro Tem Smith seconded. The Vote: Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0) The Clerk read the Bill.

Councilman Davis moved to accept the First Reading of BILL NO. 24-21, waive the rule and place the Bill on its Second and Final Reading. Mayor Pro Tem Smith seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0) The Clerk read the Bill.

Councilman Davis moved to accept the Second and Final Reading of BILL NO. 24-21 and enact the Bill as Ordinance 4.675\*. Mayor Pro Tem Smith seconded.

Mayor Pro Tem Smith expressed his concern about the existing traffic patterns of the location. He also believed fuel trucks would not be able to maneuver into and out of the site without impeding traffic and blocking without impeding traffic and blocking one (1) if not two (2) of the Post Office driveways. He shared that his experience and first-hand knowledge about the traffic in that area influenced his concern.

Councilmember Moore reported that she has observed the traffic in that area for several weeks and was concerned about the congestion in that area and agreed with Mayor Pro Tem Smith that it would create a traffic hazard. She added that it would not just be the fuel trucks, but the many other delivery trucks that provide goods to a gas station and she could not support it.

Councilman Davis reported that he could not support it based on the traffic patterns and feared emergency services vehicles could not get through the path if fuel trucks were blocking lanes of traffic.

Roll Call vote: "aye", Councilman Garnos, "nay", Councilman Davis, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (4-1)

\* Bill No. 24-21, did not pass; therefore, Ordinance No. 4.675 is now associated with Bill No. 24-22.

Mayor Pro Tem Smith moved BILL NO. 24-22 be placed on its First Reading. Councilmember Moore seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0) The Clerk read the Bill.

Mayor Pro Tem Smith moved to accept the First Reading of BILL NO. 24-22, waive the rule and place the Bill on its Second and Final Reading. Councilmember Moore seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0) The Clerk read the Bill.

Mayor Pro Tem Smith moved to accept the Second and Final Reading of BILL NO. 24-22 and enact the Bill as Ordinance 4.675\*. Councilmember Moore seconded.

Roll Call vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0) Mayor Spallo stated BILL NO. 24-22 stands enacted as Ordinance Number 4.675.

Councilman Garnos moved BILL NO. 24-23 be placed on its First Reading. Councilman Davis seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0) The Clerk read the Bill.

Councilman Garnos moved to accept the First Reading of BILL NO. 24-23, waive the rule and place the Bill on its Second and Final Reading. Councilman Davis seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0) The Clerk read the Bill.

Councilman Garnos moved to accept the Second and Final Reading of BILL NO. 24-23 and enact the Bill as Ordinance 4.676. Councilman Davis seconded.

Roll Call vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, Mayor Pro Tem Smith, and Mayor Spallo. (5-0) Mayor Spallo stated BILL NO. 24-23 stands enacted as Ordinance Number 4.676.



#### AGREEMENT FOR PROVISIONS OF THE FOLLOWING SERVICES

THIS AGREEMENT between Northland Neighborhoods, Inc. an entity organized and existing under the laws of the State of Missouri, with its principal office located at 5340 NE Chouteau Trafficway, Kansas City, Missouri 64119, hereafter referred to as the "Consultant" and the City of Gladstone, Clay County, Missouri, a Third Class City organized and existing under the laws of the State of Missouri with its principal office located at 7010 N. Holmes Street, Gladstone, Missouri 64118, hereafter referred to as the "City".

This agreement represents the entire understanding and agreement between the parties. Northland Neighborhoods Inc., is an independent consultant and reserves the means and methods of accomplishing the Scope of Services as specified in Article IV of this agreement.

Postage, printing and such other equipment, tools and supplies necessary to perform the Scope of Services as specified in Article IV of this agreement will be the responsibility of the consultant.

#### ARTICLE II

Any agreement cancellation notice shall not relieve the consultant of the obligation to deliver and/or perform on all outstanding orders issued prior to the effective date of cancellation, nor shall it relieve the city of its obligation for payment of fees for documented work within the scope of services as specified in Article IV of this agreement prior to the effective date of cancellation.

The consultant reserves the right to cancel and terminate this agreement in part or whole without penalty upon thirty (30) days written notice to the city. Any agreement cancellation notice shall not relieve the consultant of the obligation to deliver and/or perform on all outstanding orders issued prior to the effective date of cancellation, nor shall it relieve the city of its obligation for payment of fees for documented work within the scope of services as specified in Article IV of this agreement prior to the effective date of cancellation.

#### ARTICLE III

#### DRUG/CRIME FREE WORK PLACE

The consultant acknowledges and agrees that the following acts are prohibited:

- 1. The unlawful manufacturing, distributing, dispensing, possession and/or use of alcohol or drugs; and/or
- 2. Any impairment or incapacitation from the use of alcohol or drugs (except the use of prescription drugs for legitimate medical purposes); and/or

- 4. Consultant will assist Gladstone's Neighborhood Commission with guidance on their home improvement grant program.
- 5. Consultant will help organize/reorganize Neighborhood Home Organizations that want to organize/reorganize.
- 6. Consultant will provide at no cost to the neighborhoods the opportunity to print newsletters. (must adhere to NNI's guidelines)
- 7. Consultant will monitor neighborhoods, support their individual needs and assist with long term goals if requested by neighborhood. (within NNI's guidelines)
- 8. Consultant will update Gladstone's Neighborhood Commission at their monthly meetings.
- 9. Consultant will meet monthly with the Community Development Administrator | Building Official.
- 10. Consultant will assist the City with their Neighborhood | Block Watch program.
- 11. Consultant will present an annual update to the Gladstone Neighborhood Commission and City Council.

#### ARTICLE V

#### ENTIRE AGREEMENT

# AN ORDINANCE AMENDING THE CITY CODE REGARDING ALARM SYSTEMS AND USER PERMITS.

WHEREAS, the City Council desires to amend the Code regarding alarm systems and user permits.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

**SECTION 1.** That Chapter 105, Alarm Systems, of Title V, Business and Occupations, is hereby amended to read as follows:

CHAPTER 105. - ALARM SYSTEMS

Sec. 5.105.010. - Definitions.

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

*Alarm coordinator* means the individual designated by the chief of police to enforce the provisions of this chapter.

Alarm signal means a detectable signal, audibly, visually or both, to which the police department is expected to respond on an emergency basis, generated by an alarm system, indicating the commission of, or attempt to commit, a crime, presence of medical emergency or other emergency.

Alarm system means any single device or assembly of equipment designed to signal the occurrence of an illegal entry or other emergency activity requiring immediate attention and to which the police department is expected to respond.

Alarm user means any person in possession of any building, structure or facility, or part thereof, who purchases, leases, contracts for or otherwise obtains an alarm system; any person who contracts for the servicing or maintenance of an alarm system; any person who contracts with or hires an alarm business to monitor an alarm system.

Automatic dial protection device means an electrically operated instrument composed as sensory apparatus and related hardware which automatically sends over regular telephone lines a prerecorded voice alarm upon receipt of a stimulus from the sensory apparatus that has detected a force or condition characteristic of an unauthorized intrusion or an emergency message indicating a need for emergency response.

Calendar year means each 12-month period beginning on January 1 and ending on December 31. The starting date for new systems shall be the date of the first false alarm reported by the system and the ending date shall be December 31.

Chief of Police means the chief of police of the city, or their designated representative.

False alarm means an alarm signal eliciting a response by the police department when a situation requiring an immediate response does not in fact exist, such as when no breach of security has been attempted or committed, or no emergency exists. An alarm will not be considered a false alarm if it is determined that the alarm was caused by:

- (1) Natural or manmade catastrophe or an act of God. Such events include tornadoes, floods, earthquakes or other similarly violent conditions;
- (2) Vandalism causing physical damage to the premises;
- (3) Telephone line outage;
- (4) Attempted entry of a location causing visible, physical or other evidence of damage to the location;
- (5) Severe weather causing physical damage to the premises;
- (6) The test of a local alarm system by a licensed alarm business agent or employee who is present at the premises servicing, repairing or installing the alarm when such testing does not result in the alarm being activated for an uninterrupted period exceeding 60 seconds and when the city police department has been notified of the test.

Local alarm system means an alarm system which when activated causes an audible and/or visual signaling device to be activated only on the premises within which the system is installed and which is intended to be heard or seen by others outside of the protected premises.

*Multiple false alarms* means multiple false alarms on any one system, occurring within a 24-hour period of time, shall be considered as one false alarm.

System means both local alarm systems and alarm systems.

Sec. 5.105.040. - Local alarm systems; length of alarm.

- (a) Residentially zoned property. Local alarm systems or alarm systems located within an area zoned residential or within 500 feet of an area zoned residential shall automatically discontinue emitting an audible sound within 15 minutes of activation.
- (b) *Property not zoned residential*. Local alarm systems or alarm systems located within an area not zoned residential and not within 500 feet of an area zoned residential shall automatically discontinue emitting an audible sound within 30 minutes of activation.

(Code 1974, § 2.1-4)

Sec. 5.105.050. - Automatic dial protection devices prohibited.

- (a) Report of recorded message. No automatic dial protection device shall be used to report, or cause to be reported, any recorded message directly to the city police department, without the prior permission of the chief of police.
- (b) *Exception*. Direct dial systems in place as of the effective date of the ordinance from which this chapter is derived.

Sec. 5.105.080. - Review of false alarm determinations.

- (a) Notice. At the time of the sixth false alarm for any alarm user within any calendar year, the alarm coordinator shall notify the alarm user by personal service upon the addressee, or given by United States mail of such occurrence and that additional false alarms during the calendar year may require the alarm user's appearance in municipal court.
- (b) Review of false alarm determinations. The city police department alarm coordinator shall, when requested by an alarm user, review the determination that an alarm was false. Such review may be done by the alarm coordinator only if the alarm user requests such a review within 15 days of the mailing or other delivery of the notice of the sixth false alarm determination. A request for a determination by the alarm coordinator shall include at least the following information:
  - (1) Alarm user name;
  - (2) Address at which alarm is installed;
  - (3) Date(s) of alarm or alarms being contested;
  - (4) Facts upon which the request for a review of determination is made.

(Code 1974, § 2.1-8; Ord. No. 4.558, § 1(Exh. A), 6-14-2021)

Sec. 5.105.090. - Violations.

- (a) It shall be unlawful for any person to violate any provision of this chapter.
- (b) It shall be unlawful to use an alarm system or local alarm system which reports, or causes to report, seven or more false alarms within a calendar year. Such violations shall be subject to the penalties outlined in subsection 5.105.100(b).

(Code 1974, § 2.1-9)

Sec. 5.105.100. - Penalties.

(a) Any person convicted of violating any provision of this chapter shall, unless the specific penalties of subsection (b) of this section apply, be punished by a fine of not less than \$50.00 or more than \$500.00, or by imprisonment for a period not to exceed 180 days, or by both such fine and imprisonment.

- (b) Any alarm system which has recorded more than six false alarms within a calendar year shall be subject to the following fines:
  - (1) Seven through ten false alarms, \$25.00 each.
  - (2) Eleven through 15 false alarms, \$50.00 each.
  - (3) Sixteen through 20 false alarms, \$75.00 each.
  - (4) Twenty-one and each subsequent false alarm, \$100.00 each.
- (c) Each day of violation of any provision of this chapter shall constitute a separate offense.

(Code 1974, § 2.1-10)

# AN ORDINANCE AMENDING THE CITY CODE TO ADDRESS VEHICLE SIDESHOWS AND STREET RACING.

WHEREAS, the City Council desires to amend the Code to add prohibitions on the vehicle "side-shows" and street racing.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

**SECTION 1.** That Title III, Offenses, is hereby amended to add a new chapter, Chapter 150, Vehicle Sideshows and Street Racing, to read as follows:

CHAPTER 150 - Vehicle Sideshows and Street Racing.

SECTION 3.150.010 Spectator or unlawful assembly at drag race or speed competition.

- A. Except as provided elsewhere in this chapter, no person shall knowingly be present as a spectator, either on a public street or highway, or on private property open to the general public without the consent of the owner, operator, or agent thereof, at a drag race or illegal motor vehicle speed competition.
- B. Except as provided elsewhere in this chapter, no person shall be present as a spectator, either on a public street or highway, or on private property without the consent of the owner, operator, or agent thereof, where preparations are being made for a drag race or illegal motor vehicle speed competition.
- C. An individual is present at the drag race or illegal motor vehicle speed competition if that individual is within 200 feet of the location of the event, or within 200 feet of the location where preparations are being made for the event.
- D. When two or more persons assemble to witness or participate in a drag race or illegal motor vehicle speed competition such assembly is an unlawful assembly and any person who participates in such unlawful assembly is guilty of an offense.
- E. Exemption: Nothing in this section prohibits law enforcement officers or their agents from being spectators at drag races or speed contests in the course of their official duties.

**SECTION 2.** That this Ordinance shall be in full force and effect from and after the date of its passage and approval.

**SECTION 3.** That all Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed.
