The agenda was approved as published.

Burt Comstock, 7600 N. Park, addressed the Council. He expressed gratitude to the City Council, City Manager, and the Police Department for addressing NE 76th Street traffic concerns.

Item No.9.On the Agenda. Communications from City Council.

Councilmember Moore thanked the volunteers, particularly Councilman Garnos and his wife for joining clean-up efforts with the Glad Green Team on Saturday, September 7, 2024. She encouraged all to join the Glad Green team to continue to beautify the City.

Mayor Spallo reported that she attended the recent Neighborhoods Commission meeting discussing the Neighborhood Grant Program and out of thirty-two (32) applications received, fifteen (15) qualified. She added that City staff are reviewing the applications and conducting site visits to ensure qualifications are met. She thanked Alan Napoli, for overseeing the program and expressed her excitement as the Commission liaison. She acknowledged the anniversary of the terrorist attacks on September 11th and asked for a moment of silence to remember the lives lost.

Councilman Davis moved to approve the Consent Agenda as published. Councilmember Moore seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, and Mayor Spallo. (4-0)

Councilman Davis moved to approve the SPECIAL EVENT PERMIT: Seventh-Day Adventist Church hosting a Health and Wellness Expo, Gladstone Community Center, 6901 North Holmes, Sunday, September 29, 2024, 10:00 am to 3:00 pm. Councilmember Moore seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, and Mayor Spallo. (4-0)

Councilman Davis moved to approve RESOLUTION R-24-59, A Resolution authorizing the City Manager to enter into an agreement with Zoll Medical Corporation for the purchase of a three-year extended warranty and preventative maintenance plan for all six (6) Zoll X-Series Cardiac Monitors in service with the Gladstone Fire Department in the total amount of \$31,338.00. Councilmember Moore seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, and Mayor Spallo. (4-0)

Councilman Davis moved to approve RESOLUTION R-24-60, A Resolution authorizing acceptance of a proposal from Independent Salt Company for the purchase of snow removal salt.

Councilmember Moore seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, and Mayor Spallo. (4-0)

<u>Item No. 12. On the Agenda.</u> FIRST READING BILL NO. 24-26, An Ordinance approving the Final Plat of a Minor Subdivision Replat of Part of Lot 3, Commissioners' Plat of Palmer Home in Gladstone, Clay County, Missouri, and directing the appropriate officials to affix their signatures to said Plat for recording.

Mayor Spallo announced that Assistant City Manager Greer would provide information for both the Replat and the requested zoning change of the property, which is the same information for the Public Hearing and the explanation would be given once.

Assistant City Manager Greer explained the following: Mr. Roger Wilson is requesting a re-plat and re-zone of 1.49 acres located at 300 NE 58th Terrace. Mr. Wilson plans to keep Lot 1 (1 acre) and sell Lot 2 (0.49 acres) which has an existing building, parking spaces and playground. Historically, the building located on Lot 2 has been operated as a private childcare facility in an existing nonconforming way, but is the incorrect zoning for this type of use. Since the property is being re-platted and sold, City Staff and the applicant believe that this is an opportune time to remedy the split-zoning situation and bring the property into compliance with a private childcare and school type of use. He continued that Mr. Wilson has shared with City Staff that Lot 2 is currently under contract to be sold to Alecia and Deron Jones who own Brighton Learning Center, which is a private childcare facility. Mr. and Mrs. Jones own and operate two (2) other child care facilities within the City of Gladstone and are looking to expand once again at this location. He shared that currently, this property is a splitzoning of R-3 Garden Apartment Residential and CP-0 Planned District, Non-Retail (Office) and in order to legally operate a private school or childcare facility, Lot 2 will need to be re-zoned to CP-1. Planned Local Business District. Furthermore, given the property's close proximity to the N. Oak Trafficway commercial corridor and its surrounding zoning designations and uses, he stated it is City Staff's opinion that re-zoning this property from CP-0 to CP-1 is an adequate solution and City Staff recommends the request be approved. The Planning Commission's unanimously voted 10-0 for approval of both projects.

Mayor Spallo stated that she would accept a motion for the First Reading of Bill No. 24-26.

Councilmember Moore moved BILL NO. 24-26 be placed on its First Reading. Councilman Garnos seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, and Mayor Spallo. (4-0) The Clerk read the Bill.

Councilmember Moore moved to accept the First Reading of **BILL NO. 24-26**, waive the rule and place the Bill on its Second and Final Reading. **Councilman Garnos** seconded. The Vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, and Mayor Spallo. (4-0) The Clerk read the Bill.

Councilmember Moore moved to accept the Second and Final Reading of BILL NO. 24-26 and enact the Bill as Ordinance 4.679. Councilman Garnos seconded.

Roll Call vote: "aye", Councilman Davis, Councilman Garnos, Councilmember Moore, and Mayor Spallo. (4-0) Mayor Spallo stated BILL NO. 24-26 stands enacted as Ordinance Number 4.679.

<u>No. 13. On the Agenda.</u> PUBLIC HEARING: Zoning Change for Lot 2 of Commissioners' Plat of Palmer Home in Gladstone, Clay County, Missouri.

Subject: Contract Award, Bulk Purchase of Unleaded and Diesel Fuel

<u>Background</u>: Kansas City, Missouri (KCMO) recently bid and awarded a contract to Frazier Oil Company for the bulk purchase of unleaded and diesel fuel. That contract included cooperative language and pricing that would result in a savings of approximately \$0.40 per gallon for the City of Gladstone. The City currently purchases fuel from World Fuel Services, Inc.

<u>Budget Discussion</u>: Funds are budgeted in the amount of \$280,500 in the General Fund, PSST, and CWSS Funds.

<u>Public/Board/Staff Input:</u> The City currently uses approximately 4,300 gallons of unleaded fuel and 1,200 gallons of diesel fuel each month. It is estimated that the City would save approximately \$26,400 annually based upon KCMO pricing. Staff recommends that the City of Gladstone execute a one-year contract with Frazier Oil Company for the purchase of unleaded and diesel fuels. The City does not have a contract with World Fuel Services, Inc., however, they would be available as a backup supplier in the event of an emergency.




Financial Report for 2 Months Ending August 31, 2024


GENERAL FUND

General Fund Revenues

Total revenues for the General Fund through 2 months or 17% of this fiscal year are \$4,308,065 compared to total budgeted revenues for the year of \$23,700,945 or 18% of budgeted revenue. Property tax revenue is \$38,515. Sales tax on a cash basis is \$1,516,553 or \$56,647 (4%) less than last year due to decreases from use tax. Gross receipts taxes are \$683,183, an increase of \$268,384 due to timing and increased electricity gross receipts. License and Permit revenues are \$405,537, or comparable to the same period in FY24. Intergovernmental revenue is \$362,161 or \$17,982 (5%) over the previous year due to increased receipts from the state gas tax. Charges for Services are \$838,755 an increase of 3% or \$21,581 compared to the previous year due to senior activities. Fines and Forfeitures have increased (7%) from the same time last year to \$54,669. Miscellaneous Revenue is \$233,692, a decrease of \$17,515 due to decreases in tower rental receipts. Debt proceeds are not budgeted for the fiscal year. Transfers into the fund are \$175,000. No equity transfer is budgeted for the General Fund, at this time.









Expenditures through 2 months or 17% of this fiscal year amounted to \$4,219,780 or 18% of FY25 budgeted expenditures of \$23,700,945. This indicates that actual expenditures are 17% or \$842,385 less than last year's expenditures of \$5,062,165 (mainly due to differences in capital purchases from the previous year). General Administration expenditures are \$226,956, an increase of \$49,168 or 28% due to changes in personnel and completion of the Code of Ordinances update. Finance expenditures have decreased \$39,500 to \$229,969 due to timing of contractual obligations. Police expenditures are \$843,954, a decrease of \$75,088 due to open positions. Fire/EMS expenditures have increased \$47,405 to \$655,414, due to uniforms and vehicle maintenance. Public Works expenditures are \$293,444, \$35,432 or 11% less than the prior year due to the timing of supplies purchases and open positions. Community Development expenditures are \$129,004, a decrease of \$3,447. Parks & Recreation expenditures are \$364,580, down \$76,710 from the same time last year due to changes in personnel. Non-Departmental expenditures are \$627,748, an increase of \$15,988 due to the increases in property and liability insurance. Capital Outlay is \$24,350 (decrease due to the lease purchases in the previous year). Payments for debt have increased by \$400,304 to \$474,361 due to the 2024 lease purchases and pay off of A.J. Farm note. Transfers to from the General Fund are \$350,000. Current revenues exceed current expenditures by \$88,285.


COMBINED WATER AND SEWERAGE SYSTEM FUND

Total budgeted revenues for the fiscal year are \$13,214,010. Total revenues through 2 months or 17% of this fiscal year, amounted to \$2,296,726 or 17% of FY25 budgeted revenues. Decreases in both sanitation and water revenues are due to decreased water and sewer usage. Miscellaneous revenue is \$73,281 due to interest from the 2024 COP. There are no debt proceeds budgeted for FY25.







Total budgeted expenditures for the fiscal year are \$13,214,010. Total expenditures through 2 months or 17% of this fiscal year amounted to \$2,503,358 or 19% of FY25 budgeted expenditures. Production expenditures are \$178,212, a decrease of \$4,479. Operations division expenditures are \$161,014, an increase of \$9,095. Sewer division expenditures have increased \$68,818 to \$111,918 due to the timing of sewer line maintenance. Non-departmental expenditures are \$1,582,857, an increase of \$15,340 due to increase in liability and property insurance and sewage treatment. Capital outlay is \$26,910. Payments for debt increased to \$392,447. Transfers out of the fund are \$50,000. Current expenditures exceed current revenues by \$206,633.




COMMUNITY CENTER AND PARKS TAX FUND




Total budgeted revenues for the fiscal year are \$4,795,890. Total revenues through 2 months or 17% of this fiscal year, amounted to \$1,305,064 or 27% of FY25 budgeted revenues. Sales tax received is \$179,462, a decrease of \$3,300 (2%) from the previous year. Intergovernmental revenue consists of a charge to the North Kansas City School District for the natatorium \$725,000. Revenue from the NKC School District is usually received in January. Charges for Services are \$296,842, an increase of \$4,141. Revenue from facility rental is \$35,636, an increase of 13% or \$4,141. Miscellaneous revenue is comparable to the previous year at \$7,124. Transfers to the fund are \$786,000. An equity transfer of







Total budgeted expenditures for the fiscal year are \$4,795,890. Total expenditures through 2 months or 17% of this fiscal year amounted to \$657,379 or 14% of FY25 budgeted expenditures. Community Center expenditures are \$153,129, or 8% more than the previous year due to changes in personnel. Natatorium expenditures decreased \$65,212 from the previous year to \$81,295 due to building maintenance. Outdoor Pool expenditures are \$106,173. Non-departmental expenditures have increased 15% to \$174,284, due to increases in property and liability insurance. Capital outlay is \$121,881. Payments for debt are \$20,617. Current revenues exceed current expenditures by \$647,685.

PUBLIC SAFETY SALES TAX FUND



Total budgeted revenues for the fiscal year are \$1,130,000. Total revenues through 2 months or 17% of this fiscal year amounted to \$186,437 or 16% of FY25 budgeted revenues. Sales tax on a cash basis is \$179,453, or a decrease of \$3,305 (2%). Miscellaneous revenue is \$6,984. An equity transfer for the PSST Fund is not budgeted, at this time.





Total budgeted expenditures for the fiscal year are \$1,130,000. Total expenditures through 2 months or 17% of this fiscal year are \$135,699 or 12% of the FY25 budgeted expenditures. Law division is \$118,372, an increase of \$20,920 from the same time last year due to filled positions. Non-Departmental is \$17,327, compared to \$17,327 during the previous year. Capital outlay is \$0. Debt is budgeted at \$198,00, and will occur later in the fiscal year. Current revenue over expense for the fund is \$50,738.

Subject: Property Tax Levy

Background: A notice of public hearing to set the real and personal property tax rates for the City of Gladstone was advertised on September 12, 2024. The public hearing was advertised to take place on September 23, 2024. Staff received final valuations from Clay County on September 10th. Something to consider is that 2024 is a non-assessment year. Residential real property valuations increased \$409,290 to \$363,293,410. Agricultural real property valuations stayed the same at \$49,690. Commercial real property decreased \$583,658 to \$94,943,516. Total real property valuation is \$458,695,906. Personal property decreased \$3,537,203 from the previous year to \$86,272,033 for the current year. Staff promptly entered the final valuations into the State Auditor's property tax calculator. Due to the calculation and valuation, the levy for residential real property will be set at 0.700 per \$100 (increase of 0.008 from 0.692 in 2023), agricultural property will be set at 0.581, and commercial real property will be set at 0.709 per \$100 (increase of 0.013 from 0.696 in 2023). Personal property will continue to be set at 0.929 per \$100. Projected revenue from the 2024 property tax levy is estimated to be \$3,219,358 from real property and \$801,467 from personal property for a total of \$4,020,825 if 100% of the levy is collected.

Budget Discussion: N/A.

<u>Public/Board/Staff Input:</u> To get the public hearing notice advertised within the legal guidelines, the public hearing notification was sent out using estimated values. Final valuations were on September 10th. Calculations from the resolution and RCA are based on final valuations.
