### Item 2. On the Agenda. ROLL CALL.

Mayor J. Brian Hill opened the Regular September 8, 2014, City Council Meeting at 7:50 PM in the Gladstone City Council Chambers, and noted all City Council members were present.

#### Item 3. On the Agenda. PLEDGE OF ALLEGIANCE.

Mayor J. Brian Hill asked everyone to join and to please rise for the pledge of allegiance.

<u>Item 4. On the Agenda</u>. APPROVAL OF THE AUGUST 25, 2014, REGULAR CITY COUNCIL MEETING MINUTES.

Mayor J. Brian Hill introduced former Mayor Wayne Beer for this presentation. Mr. Beer thanked the Council and introduced his fellow Legionnaires: Gerald Braton, 2<sup>nd</sup> Vice Commander, Phyllis Rosales, Post Adjunct, Nelson Duncan, 1<sup>st</sup> Vice Commander, and Bob Box, Finance Officer. Mr. Beer stated this presentation goes back to the Armed Forces Day, Memorial Day event, and most specifically the Flag Pole Dedication. As you may remember, the Flag Pole Dedication weather was really quite horrible. It was a downpour. Mr. Beer said he truly expected that event to be cancelled, but when they got there, they saw two drowned rats, and a bunch of tents set up that he truly did not expect to see. For going beyond the call of duty in order to get ready for this event, Richard King and Paula Brooks excelled. Some consider this type of action to be just part of the job, and while that may be, it still was beyond the call of duty. Mr. Beer asked Paula Brooks and Richard King to come forward to accept their Certificate of Appreciation and Recognition. The American Legion truly appreciated all they did in order to get the Memorial Day Celebration ready. Mr. Beer thanked the Council. This was followed by applause from the audience.

Mayor J. Brian Hill stated it did turn out to be a successful event despite the weather. Mayor Hill thanked Paula Brooks and Richard King for their efforts.

Mr. Beer stated it was brought to his attention that since Mr. Millison was out front taking pictures, and not sitting in front of Mr. Beer when Mr. Beer introduced the members of the American Legion; Mr. Beer introduced Doug Millison, Communications and Historian for the American Legion.

### Item 7. On the Agenda. COMMUNICATIONS FROM THE CITY COUNCIL.

Councilmember Jean Moore stated she wanted to give KUDOS to all the individuals who were so involved in the Big Shoal Fair on Saturday. It was a rousing success. There were about 1200 people which is double the attendance from the prior year. It was great weather and a lot of effort went in to planning that event. KUDOS to all involved who made that happen.

Councilman R.D. Mallams stated he echoed what Councilmember Moore said. On Saturday, Councilman Mallams worked at the Big Shoal Country Fair. Weather wise, obviously, it was absolutely wonderful. Councilman Mallams expressed his appreciation to all members of the City Staff who worked to make this event a huge success.

Councilmember Carol Suter stated to all those who volunteer and the Friends of the Atkins Johnson Farm who worked so hard, if you start more than a year ahead the event comes together better and was very well organized this year in the planning process. It paid off because they are counting over 1300 people perhaps in attendance. That is about 30% above goal, which goal was about 1000.

Councilmember Carol Suter gave KUDOS to legal counsel and to outside legal counsel for winning one in court, when we were trying to stay one step ahead of the state legislature that is determined to hurt cities any way they can, it's a hollow victory when we won and stopped the 2013 legislation that was harmful; but of course the legislation came back in 2014 and did it again. Good legal work, and she appreciates it.

Mayor Pro Tem Bill Garnos stated the Building Commission meets Thursday, September 11, and there will be a Public Hearing. Mayor Pro Tem Garnos thanked everyone in town for their patience with the various construction projects that are going on, particularly 76<sup>th</sup> Street and North Oak. Some of these projects require a lot of patience to get through, but it is exciting to see them done and it will be great once it is completed. Everyone needs to be patient between that and the sidewalks and the Google Fiber installation. In a month or two things will be much better.

Mayor J. Brian Hill echoed what everyone else has said about the great event at the Atkins Johnson Farm, the Big Shoal Country Fair. The weather was great. A lot of people showed up and enjoyed the festival. Without city staff and all the efforts of the many, many volunteers, it would not have been possible. Mayor Hill expressed his thanks to all of them.

Mayor J. Brian Hill stated it is frustrating to deal with all the construction in town but we also need to realize it's exciting to have that kind of growth and potential that is being realized. Mayor Hill mentioned this Friday at 7:00 pm, Riverrock plays at Linden Square and the following Friday, September 19, the Nace Brothers will perform at 7:00 pm. The Farmers Market is open every Wednesday and Saturday in the Hy Vee parking lot and has been amazingly successful this year and has grown quite a bit over prior years. This is largely due to the efforts of Ms. Jarrett and the Mayor thanked Ms. Jarrett.
