Item No. 8. On the Agenda. Communications from the City Council.

Councilmember Suter stated she wanted to express her appreciation and enthusiasm to Oak Hill Day School and their renovation project of what used to be the Gladstone Office Building. She was lucky to get in on one of the hard hat tours that they did last week. There is a lot to be done over there but they assure us it is going to be ready for school, that even makes Councilmember Suter nervous; if she was trying to renovate a house in that situation but it will be quite an exciting project and it is really exciting to see the large vision the school has for growth and to serve a wider segment of the community in that project. Councilmember Suter stated that she wondered, in light of what has been going on in the universe in the last two months anyway, she was intrigued by Blue Springs and the success they have had at reducing the number of what seem to be unnecessary traffic stops for persons of color in Blue Springs and she knows that Gladstone keeps track of that and she was wondering if, as Council, they may be able to get access to our history of how that has been going in Gladstone.

Councilman Garnos reported they had a good Parks and Recreation Advisory Board meeting last week. They had project updates on Hobby Hill, the Community Center renovations and Rock Creek Trail. They also talked a little bit about the Little Gully play structure that was approved last meeting, and Director Murkey had some terrific ideas for using that to help engage the neighborhood instead of just putting it in there and walking away. There was some really good discussion about ideas for using that to help organize and revitalize the whole neighborhood and starting with that. Councilman Garnos was very pleased with that thought. There was also an update on Gladstone Shaping Our Future, the volunteer work from the Antioch Bible Baptist and the new climbing wall at the pool that will be replacing the high dive, which we had to take out.

Mayor Moore stated she had a couple of things. Mayor Pro Tem Mallams and she and city staff had an opportunity to go to the Missouri Municipal League Civic Leadership Award event last week where former City Manager Kirk Davis was honored and that was a nice event as always. It was nice to honor Kirk Davis. Mayor Moore extended her thanks to all those at Linden Square who work so tirelessly every Friday and Saturday when we have an event there and that is Parks and Rec staff, volunteers, and Public Works, and Public Safety. The FAD event on Friday night, the Food, Art, Drink event, was obviously a first time out of the box for Gladstone with that event but it was very hot, despite that, well attended and a great start on that event. People had fun with the music and the art and she thought it was an event that we could build on, maybe when it's not so hot! Mayor Moore thinks that would help out a lot. KUDOS to all those people, every time we have an event at Linden Square there is a lot of people working behind the scenes to make all of our programming possible there and she knows that they sometimes are under

duress in terms of the weather conditions to make those volunteer efforts happen, and she wanted to express her appreciation, it means a lot to the community for those events.

Item No. 9. On the Agenda. Communications from the City Manager.

City Manager Scott Wingerson thanked the Mayor and Council and stated he had a couple of quick things to follow up on what has already been said. First, the climbing wall was installed Monday July 25 at the outdoor pool. When you leave here tonight you will be able to see it if you like. Quite interesting and looks like fun for the kids, although he is not going to participate in that. The Mayor talked about the Food, Art, Drink event. It was hot but certainly something there to grow. Very, very successful overall, a great event, high caliber, so much work went into it, so thanks to staff and volunteers just as the Mayor stated. Saturday was Fun in the Sun kids fest event. About 400 kids participated on Saturday during the day, so it was ridiculously hot again at that point, again thanks to the people that participated and the staff. Saturday evening, to conclude the Linden Square events, was Movie in the Park, and about 100 people went to that. Something special happened. Public Safety brought popsicles out to all families and kids, so very much a thank you to them for engaging the public in law enforcement especially with all the weird things that are going on in the world today. KUDOS to the Parks & Recreation, Cultural Arts Department staff and the volunteers and also to Public Safety for taking that extra step to really do a great thing. This weekend, coming up, Sounds on the Square Friday night concert series is a band called Allied Saints, Friday July 29 at 7:00 pm and Theatre in the Park in Oak Grove, Shrek, August 5-7 and all the shows start at 8:30.
