Item No. 9. On the Agenda. Communications from the City Council.

Councilmember Suter stated: "I have two quick things. 72nd Street looks really good now that it has been resurfaced and painted. I hope we can get MODOT to paint the intersection because the lane lines are all gone and increasingly in the last six to eight months we just keep finding people in the wrong lanes a lot at that intersection making three lanes going across instead of just two. I was sorry to miss the Northland Neighborhood's event but I wanted to express my congratulations to Alan Napoli for winning their award, well deserved, sir."

Mayor Moore stated: "I will echo Councilmember Suter's comments. We are very proud of you, Alan. That was a well-deserved honor and it was a pleasure to be there at the breakfast. Mayor Pro Tem Mallams and I were there as well as the City Manager and other city staff. We enjoyed the breakfast and seeing you make Gladstone even prouder. Thank you."

Mayor Moore stated: "It is my responsibility to appoint Board members to the Meadowbrook Shopping Center Community Improvement District. There are four of those individuals. Jon Carpenter, for a term expiring July 1, 2020. Chris Gahagen for a term expiring July 1, 2020. Dave Stanley for a term expiring July 1, 2020, and James Stewart III, for a term expiring July 1, 2018. Are there any comments, issues, from the rest of the Council? If not we will appoint those members to the Meadowbrook Shopping Center CID. Do we need to vote?"

City Counselor Williams stated, "Yes we do. I think it says with the advice and consent of the Council. Sort of like the Supreme Court Justices."

City Manager Scott Wingerson stated: "Mayor, thank you very much. Fairly quickly, I want to take a second to also congratulate Alan. Alan embodies the spirit of Rich Noll, who the award is named after and as we get further and further away from Rich's passing it is just nice to know that someone from Gladstone will be carrying on those ideals. It's fantastic. Congratulations Alan, Also KUDOS to Community Development, Carole McGuire is our Permit Technician and sometimes Carole's job is to ask people nicely to mow their grass when it gets slightly too long and sometimes they choose not to do that and sometimes Carole gives the order to have the property mowed and the property invoiced. So, you can imagine that is not always a pleasant set of circumstances when that happens. One particular person who that happened to though, talks to kind of the mission for customer service and difficult circumstances, says to Carole: 'Thanks again for always being so helpful. We love being property owners in Gladstone. Thank you very much.' So even in those difficult circumstances, Carole has done a wonderful job in communicating our public service, our community service, and our customer service ideals. Couple of events in the past: Friday Fright Night was in Oak Grove Park last Friday. About \$450.00 in donations and about 400 canned goods were collected for the Christmas Store. Very happy about that. A total of 425 kids participated and about 700 total number of people with kids and adults. Special compliments and shout-outs to Director Merkey and the Parks Department as well as the Gladstone Chamber of Commerce who is a co-sponsor in that event. Things coming up: tomorrow night, from 7:00 to 8:00 pm, Pie with the Police at Linden Baptist Church. Everyone is invited. On Halloween, October 31st at 5:30 pm to 6:30 pm in City Hall customer parking lot is Trunk or Treat with our Public Safety Department. Everybody is invited to do that safely. Two more quick things. One is that the Council just awarded the Pleasant Valley Road construction contract at about \$5.3 million dollars; that represents a savings of almost \$300,000.00 from what we thought it was going to cost. Compliments to Tim and his staff in Public Works of doing a good job engineering that project. Finally, we lost somebody last week. Mark Bardezbain, unexpectedly. I want to let you know our continued thoughts go out to his family and the co-workers here who have been hit pretty hard by that. We are going to miss Mark, he was a shining star in our organization. We had great things planned for him. We are going to miss him a lot as we move forward."
