AN ORDINANCE AMENDING TITLE V, CHAPTER 110, SECTION 5.110.3600(a) OF THE CITY OF GLADSTONE, MISSOURI'S MUNICIPAL CODE RELATING TO REGULATION OF THE SALE AND CONSUMPTION OF LIQUOR TO INCREASE THE LIMIT ON THE NUMBER OF CLASS B (SUNDAY SALES) LICENSES.

WHEREAS, Section 5.110.3600 of the Municipal Code ("Code") of the City of Gladstone, Missouri ("City") establishes limits on the number of licenses to be granted for various classes for the sale of any intoxicating or malt liquor in the City; and

WHEREAS, subsection (a) of Section 5.110.3600 of the Code limits the number of Class B licenses for Sunday sales to 30; and

WHEREAS, the City has received applications at various times for Class B Sunday sales licenses that exceed the limit of 30; and

WHEREAS, the City Council desires to amend its Code to increase the number of Class B licenses for Sunday sales from 30 to 35.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GLADSTONE, MISSOURI AS FOLLOWS:

Section 1. That Section 5.110.3600(a) of the Code be amended to increase the number of Class B (Sunday sales) licenses and to read as follows:

Sec. 5.110.3600. Number of licenses to be granted for each classification.

(a) The number of licenses for the sale of all intoxicating liquor or malt liquor by the drink and in the original package are limited by class as follows:

Class A (1)	15
Class A (2)	15
Class A (3)	10
Class A (4)	10
Class A (5)	25
Class A (6)	30
Class B (1)	35

Section 2. That this Ordinance shall be in full force and effect from and after the date of its passage and approval.

Section 3. That all ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

Increase in Number of Sunday Sales Liquor Licenses

In August 2014, the City Council adopted Ordinance No. 4.284 enacting new Municipal Code provisions regulating the granting of liquor licenses and the sale and distribution of alcoholic beverages in the City. These new provisions established various classes of licenses including the Class B licenses for Sunday sales of intoxicating liquor or malt liquor by the drink and in the original package as allowed by State law. The provisions also established limits on the number of licenses to be issued for each class. The number of Class B licenses is currently limited to 30. Over the past year, the City Clerk has indicated that the City has received applications for Class B licenses at various times that exceed this limit. As a result, it is recommended that the limit for Class B licenses be increased from 30 to 35 to allow additional Class B licenses for Sunday sales to be issued in accordance with the Code provisions and as allowed by State law.
