

**AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A PROGRAM AGREEMENT BETWEEN THE CITY OF GLADSTONE AND THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION FOR FEDERAL SURFACE TRANSPORTATION PROGRAM FUNDS RELATED TO THE CONSTRUCTION OF PLEASANT VALLEY ROAD IMPROVEMENTS FROM NORTH INDIANA AVENUE TO NORTH BRIGHTON AVENUE; CITY PROJECT #TP1411; FEDERAL PROJECT #STP-3323(407).**

**Legislative Findings**

1. The Moving Ahead for Progress in the 21<sup>st</sup> Century Act (MAP-21) 23 U.S.C. §133, authorizes a Surface Transportation Program (STP) to fund transportation related projects; and
2. The City of Gladstone and Kansas City, Missouri partnered together and were awarded federal funds in the amount of 80% of eligible construction costs not to exceed \$3,825,000 to construct Pleasant Valley Road Improvements from North Indiana Avenue to North Brighton Avenue; and
3. The City of Gladstone is identified as the lead agency and is required to execute this Agreement to secure these funds for construction; and
4. It is in the best interest of the citizens of Gladstone and Kansas City to work cooperatively to complete the transportation related improvements.


**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:**

**THAT**, the City Manager of the City of Gladstone, Missouri, is hereby authorized to execute an agreement with the Missouri Highways and Transportation Commission for Federal Surface Transportation Program funds related to the construction of Pleasant Valley Road Improvements from North Indiana Avenue to North Brighton Avenue.

The Cities of Gladstone and Kansas City, Missouri (KCMO) were jointly awarded \$3,825,000 through the Federal Surface Transportation Program (STP) for the construction of Pleasant Valley Road Improvements from North Indiana Avenue in Gladstone to North Brighton Avenue in KCMO.

In order to secure the funding, Gladstone must execute a program agreement with the Missouri Highways and Transportation Commission. The estimated construction cost and federal reimbursement amount for each City is summarized below:

<b>City</b>	<b>Est. Construction Cost</b>	<b>Est. Federal Reimbursement (59%)</b>
Gladstone	\$4,000,000	\$2,360,000
Kansas City	<u>\$2,500,000</u>	<u>\$1,465,000</u>
	\$6,500,000	\$3,825,000

A separate cooperative agreement will be required with KCMO to fund improvements within their municipal boundaries. City staff is recommending approval of this agreement. Construction is still on schedule to begin later this year.
