AN ORDINANCE AMENDING SECTION 6.110.570 OF THE CODE OF ORDINANCES OF THE CITY OF GLADSTONE, MISSOURI LEVYING SEWER SERVICE CHARGES AND COMMODITY RATE CHARGES IN THE CITY.

WHEREAS, pursuant to Section 250.233 RSMo., notice of a public hearing regarding proposed sewer rate changes in the City was provided by newspaper publication; and

WHEREAS, on May 23, 2016, a public hearing was held on the proposed sewer rate changes; and

WHEREAS, the City Council desires to adopt the proposed sewer rate changes as provided in this Ordinance.

# BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

<u>SECTION 1.</u> Section 6.110.570 of the Code of Ordinances of the City of Gladstone, Missouri is hereby deleted in its entirety and replaced with the following:

## Sec. 6.110.570 Sewer Service Charges and Commodity Charges.

There is hereby levied a charge against every person occupying property having a sewer connection with the city sewer system or having sewers available for connection, or otherwise, discharging sewage, industrial waste, water or other liquid into the city's sewer system, such charge to be used to pay the cost of operating, maintaining, repairing, or enlarging the existing or future sewer systems. Such charge is to be the sum of a monthly service charge and a commodity rate charge to be computed and levied as follows:

- (a) <u>Domestic Users.</u> For residential water service accounts (one and two-family residences), a monthly service charge and a commodity rate charge each as established in subsection (c) of this section, except, that for the billing periods April through December, the commodity rate charge shall be based upon the lesser of actual water used or an average of water used during the winter period of December, January, and February, billed in January, February, and March, such charges shall be payable with each bill rendered throughout the year. Where residential water service accounts do not have an acceptable history of winter water use, the commodity rate charge for the period April through November shall be the commodity rate charge established in subsection (c) of this section, or forty-three dollars and eighty six cents (\$43.86) per monthly billing, whichever is the lesser.
- (b) <u>Commercial and Industrial Users.</u> For commercial and industrial users (all persons and corporations other than the occupants of one and two-family residences), a monthly service charge and a commodity rate charge as established in subsection (c) of this section.

## (c) Charges

- (1) A monthly service charge of twelve dollars and fifty cents (\$12.50).
- (2) A commodity rate charge based on the total volume of water purchased by the customer during the billing period of \$7.84 per 1,000 gallons.

<u>SECTION 2.</u> <u>Effective Date.</u> The Sewer Service Charge and Commodity Rate Charges as set forth in this ordinance are effective May 23, 2016.

<u>SECTION 3</u>. <u>Severability</u>. The provisions of this ordinance are severable and if any provision hereof is declared invalid, unconstitutional, or unenforceable, such determination shall not affect the validity of the remainder of this ordinance.

FY16 Sewer Rate Increase

Attached is a notice received from the Water Services Department of the City of Kansas City, Missouri (KCMO). The notice indicates that new rates were approved under KCMO Ordinance No. 160165. Pursuant to Section 250.233 RSMo., a public hearing notice on the rate increase was published in the Liberty Tribune and Gladstone Dispatch on April 21, 2016. An increase is necessary to fund sewer line maintenance and EPA mandated sewer overflow program as well as infiltration projects that require all systems to be updated. As a result of the rate change, the following sewer rate adjustments will be necessary.

**Sewer Commodity Charge**: Increase from \$3.70 per hundred cubic feet to \$3.85 per hundred cubic feet in the rate charged by Kansas City to treat Gladstone's sewerage. In order to incorporate the sewer commodity charge increase and maintain sewer infrastructure, Gladstone's Sewer Commodity Rate will need to increase \$.25 from \$7.59 per 1,000 gallons to \$7.84 per 1,000 gallons per billing.

**Bimonthly Service Charge**: The current monthly service charge is \$12.40 and will increase to \$12.50 for a monthly billing.

The maximum commodity charge for Gladstone residents with no winter average and maximum service charge will total \$59.54 for monthly bills. The attached documentation provides a comparison of Gladstone's water and sewer bills with other metropolitan cities based on monthly billing.

In summary, the City of Kansas City is increasing the Sewer Commodity Charge to the City of Gladstone. The sewer commodity rate for Gladstone is proposed to increase \$.25 per 1,000 gallons and the monthly service charge will increase to \$12.50 per sewer bill.
