AN ORDINANCE AMENDING SCHEDULE V OF THE MODEL TRAFFIC CODE (CODE OF ORDINANCES, CITY OF GLADSTONE, MISSOURI, SECTION 4.100.020), TO ESTABLISH A PROHIBITION ON PARKING CERTAIN VEHICLES ON CITY STREETS.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

SECTION 1. NEW DEFINITIONS ADDED. SCHEDULE V OF THE MODEL TRAFFIC ORDINANCE (CODE SECTION 4.100.020) IS HEREBY AMENDED BY THE ADDITION OF THE FOLLOWING DEFINITIONS.

DEFINITIONS. For the purposes of this Schedule, the following words shall have the following meaning:

- (a) Recreational Vehicles. Any unit or motor vehicle designed for recreation, living, or sleeping purposes, permanently equipped with wheels or placed on a wheeled device for purpose of transporting from one place to another. This shall include, but is not limited to, camping trailers, campers, tent trailers, motor homes, tent campers, buses, snowmobiles, jet skis/wave runners, and boats of all sizes.
- (b) **Trailer.** A vehicle without motor power designed for the carrying of property, trash, debris, equipment, motor vehicles, boats, or other items.
- (c) **Parking.** The placement of a vehicle, trailer, or boat on the street for seventy-two consecutive hours within a thirty-day period.
- (d) Commercial Vehicle. A motor vehicle, truck, or box van designed or regularly used for carrying freight, merchandise, or other property, or more than eight (8) passengers, or licensed in excess of eighteen thousand (18,000) pounds, or a tractor-trailer, wrecker or tow truck designed for drawing other vehicles, including a semitrailer, or those vehicles larger than twenty-four (24) feet in length, eight (8) feet in height, and eight (8) feet in width or flatbed truck, dump truck, or cement mixer trucks including all vehicles used for commerce and vehicles displaying signage or commercial advertisements.

SECTION 2. <u>NEW "NO PARKING" PROHIBITION ADDED.</u> SCHEDULE V OF THE MODEL TRAFFIC ORDINANCE (CODE SECTION 4.100.020) IS HEREBY AMENDED BY THE ADDITION OF THE FOLLOWING RESTRICTIONS ON PARKING:

SCHEDULE V - PARKING OF CERTAIN VEHICLES PROHIBITED (AT ALL TIMES)

No. 129 ALL CITY STREETS, no person shall park or store any recreational or commercial vehicle, trailer, or box van, on any street in a residential or commercial area of the city except for the purpose of making a delivery, pickup, or other provision of services so long as such vehicles are not left continuously parked

between the hours of 11:00 p.m. and 6:00 a.m. and except for parking of recreational vehicles and trailers as provided by this ordinance.

Recreational vehicles may be parked on city streets for the purpose of loading and unloading of material(s) for no more than seventy-two consecutive hours during any thirty day period, provided the vehicle(s) are not in violation of any other provision of ordinances restricting parking.

At no time may any trailer be parked on city streets or roadways while unattached from a motor vehicle.

SECTION 3. EFFECTIVE DATE. This ordinance shall become effective sixty days from and after its passage.

RV/TRAILER PARKING RESTRICTIONS ORDINANCE

At the City Council Study Session on November 14, 2016, I presented information regarding the implementation of an ordinance restricting the parking of recreational vehicles (RVs) and trailers on city streets. The ordinance proposed establishes a prohibition of parking RVs, trailers, and commercial vehicles on any street within the city with the exception of RVs and trailers attached to vehicles for the purpose of loading/unloading material for no more than seventy-two consecutive hours within any thirty day period.

The proposed ordinance also refines the definition of "commercial vehicle" and will prohibit vehicles "displaying signage or commercial advertisements" from habitual or long-term parking on city streets. The proposed ordinance allows temporary parking of listed vehicles on city streets for the purpose of making deliveries, pickup, or other provision of services so long as the vehicles are not left continuously parked between the hours of 11:00 p.m. and 6:00 a.m. The intent of this proposed ordinance is to allow temporary parking of service vehicles (plumbers, food delivery, lawn services, electricians, etc.) on city streets. There is no prohibition for parking these types of vehicles on private property in this proposed ordinance.

This ordinance will be placed on the regular agenda for the November 28, 2016 City Council Meeting. If passed by the City Council, the ordinance would take effect after sixty days. A copy of the proposed ordinance is attached. Please advise if you need additional information.
