Item 2 on the Agenda: Pledge of Allegiance.

Item 3 on the Agenda: Approval of the January 7, 2013 minutes.

<u>Item 4 on the Agenda:</u> PUBLIC HEARING: to amend the 2008 Comprehensive Plan (Antioch Road Corridor Study) File #1375.

Planning Specialist Helmer explained that the Commission is very familiar with this amendment, as it has been presented at many meetings. He said that every couple of years they have been able to make some amendments to the Comprehensive Plan that are allowing redevelopment to

happen such as Linden Square. Several work sessions were held with the Commission beginning back in October, then with the Council in December which led to a resolution of support by the Council in January. He reminded them that final authority and amendments are the sole authority of the Planning Commission, which is why the public hearing is being held tonight. If approved this evening, the amendment becomes part of the Plan. He offered to answer any questions at this time.

Ms. Alexander asked if there was any timetable to getting this done.

Mr. Helmer said that since the Comprehensive Plan was adopted, there have been approaches made to track implementation and he will speak of that in a minute in other business.

Mr. Markenson asked if the plan has changed at all since their December 2012 meeting.

Mr. Helmer replied that there have been no changes.

Mr. Whitton asked what the condition of the water and sewer lines were along Antioch. He thought they had been upgraded a few years ago.

Mr. Wingerson answered that water, sewer and stormwater was left out of this plan because they have either been addressed in other plans or a fix has been implemented.

Chairman Turnage asked if there was anyone in favor of the application. There was no response. He then asked if there was anyone in opposition of the application. Again, there was no response. He closed the public hearing.

<u>Item 6 on the Agenda</u>: Other Business- Update on the 2008 Comprehensive Plan Implementation.

Mr. Helmer said it is not on the website because it really just started as notes to himself and evolved from there.

Ms. Smith said it might be a good thing to get out there to the public.

Mr. Ringhausen said everything looks like it is in a time frame of 1-3 years. He asked if there are other initiatives that are more long-term that are not listed here.

Mr. Helmer answered that sustainability may be one thing that contains so many items across the board that it would continue through the years. The downtown village center project would also be another one.

Item 7 on the Agenda: Communications from the City Council and the City Staff.

Councilman Hill welcomed Ms. Poindexter to the Commission. He said that planning meetings are taking place soon for Gladfest and Bluesfest. The Chamber and City Staff are seeking fresh, new ideas and they would like to hear from them. Check with Becky for dates and times of meetings.
