Item 2 on the Agenda: Pledge of Allegiance.

<u>Item 4 on the Agenda</u>: CONSIDERATION: Of a Final Plat of Johnson Farm-First Plat, located at 6613 NE Antioch Road, Gladstone, Missouri, Clay County, Missouri. File #1380.

Chairman Turnage called on Mr. Helmer for the staff report.

Planning Specialist Helmer stated that tonight's request is to simply create a newly plated parcel at the location stated above. Along with the newly created parcel is a newly created address of 6613 NE Antioch Road. He referred to the exhibit in the Commissions packets and said that this land plat will allow for separate ownership. The requested action is consistent with the

requirements of the City; therefore staff recommends approval. The City Council consideration is scheduled for April 22, 2013.

Mr. Ringhausen asked about the property immediately to the north which is marked as "unplatted" on the proposed final plat. He wondered what the difference was between the property that is being platted this evening and the surrounding unplatted area.

Mr. Helmer answered that the property to the east is still owned by the Johnson family and has not been platted. The property to the north is owned by the same property owner as this request, but is not platted. He deferred to the Mr. Roudebush of Lutjen.

Jason Roudebush of Lutjen, 1301 Burlington, North Kansas City, Missouri addressed the Commission. Mr. Roudebush said that he has been working with Mr. McConnell, who lives at the property to the northwest. Mr. McConnell has had some conversations with the Johnson's representative in purchasing the tract of land to expand his property and to ensure that no one can build next to him. He never discussed incorporating the land with Mr. McConnell's existing property.

Mr. Wingerson said that the main issue was with the strip of land, Cherry Lane, that had been previously vacated. As it turns out the lawyer that was at the hearing was correct. The City owns half of Cherry Lane and the property to the east owns the other half. In front of the City Council that was explained and also that they would be approving to the center line of Cherry Lane. Any improvements across the center lane would not be part of the application.

Mr. Markenson said that Ida McBeth was great last weekend. The facility, sound and setting [of Linden Square] is fabulous.

Ms. Alexander thanked staff for keeping them informed and for the great materials they provide them with.
