The lease with Snow & Company requires that the City make basic improvements to the property. As the Council is aware, the G18 building is in a state of disrepair and requires a new roof, new mechanical, electrical and plumbing systems, new flooring, new restrooms, new patio, and, new storefront. In anticipation of a restaurant tenant 2 years ago, the City bid these repairs. The low bid at that time was \$786,000.

In response to the Snow & Company lease, the City rebid the project. Through value engineering, the low bid is now \$499,445. The low bid contractor is Fleshman. Fleshman constructed Linden Square and the City finishes in the Pollina Building. We look forward to working with this company on the G18 project.

Staff recommends awarding this project to Fleshman in the amount of \$499,445. Funding is provided from the Capital Equipment Sales Tax Fund and the Capital Improvements Sales Tax Fund. If you should wish to discuss this matter in greater detail or desire additional information, please advise.

THIRD--This Contract is executed in quintuplicate, with distribution as specified in the Regulations of the Contract.
