Change Order 3

Project SB1291 involves the installation of approximately 550 LF of 8" sanitary sewer to serve nine (9) homes and the replacement of approximately 1300 LF of 8" water main with a history of water main breaks. This contract was awarded to Blue Nile Contractors, Inc., by Resolution R-14-28. Change Orders 1 and 2 modified the contract to include the repair of 39 meter pits and the installation of new water meters with Automatic Meter Reading (AMR) technology in the vicinity of the project.

Change Order 3 modifies the contract to include the repair of water meter pits and the installation of new AMR water meters at 60 additional locations. This change is proposed to help expedite the completion of the AMR Project (WP1385). A combination of City staff and outside contractors will be used to complete pits repairs and install new AMR meters at the approximately 800 remaining locations within the system.

Staff is recommending that Change Order 3 be added to the existing contract with Blue Nile Contractors, Inc. at a cost of \$30,000.00. Funds for this change order are provided from the Combined Waterworks and Sewerage System Funds Budget; the total amount budgeted for this project is \$2,340,000.00.
