WHEREAS, work under the contract with Ace Pipe Cleaning, Incorporated, for the 2013 Sewer Cleaning and Televisioning, Project SP1386, has been completed to the satisfaction of the Director of Public Works and the City Engineer.


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

RE: Final Pay, Project SP1386; 2013 Sewer Cleaning and Televising

Work has been completed on the referenced project and the contractor, Ace Pipe Cleaning, Inc., has made application for final pay. Staff has conducted a final inspection and determined the work to be completed in a satisfactory manner, in accordance with the specifications.

A financial breakdown is as follows:

Original Contract Amount:	\$ 67,100.00
Change Orders:	200,721.81
Revised Contract Amount:	\$ 267,821.81
Amount Paid to Date:	267,321.81
Total Amount Due Final Pay:	\$ 500.00

The initial Change Order on this project resulted from the extension of the agreement to include the 2014 Sanitary Sewer Cleaning and Televising (\$85,150.00 as authorized by Resolution R-13-46). Subsequently, a combination of City staff and outside contractors were used to complete meter pits and install new AMR meters. Ace Pipe Cleaning was authorized to perform a significant portion of this work by Resolution R-14-49 in the amount of \$60,000.00. Additional scope increases in the AMR installation work make up the balance of the change orders on this contract.

Based on all available information, the receipt of required lien waivers and the acceptance of the performed work by our staff, I am recommending that this request for final pay be placed on the next regularly scheduled City Council agenda for approval. Funds for this project are provided for from the CWSS Fund.
