WHEREAS, five proposals were received for the Northeast Englewood Road North Oak to North Flora Mill and Overlay, and the proposal of Superior Bowen Asphalt Company, LLC, in the base bid amount of \$266,526.00 has been determined by the Director of Public Works and City Engineer to be the lowest and best proposal; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

THAT, the City Manager of the City of Gladstone, Missouri, is hereby authorized to execute a contract with Superior Bowen Asphalt Company, LLC, for work as outlined in the contract for a total amount not to exceed \$266,526.00.

FURTHER, THAT funds for such purpose are authorized from the Special Road District funds and the Transportation Sales Tax fund.

Staff received the following base bids for the referenced project:

\$309,595.20

The Engineer's estimate, prepared by staff, was \$311,053.00.

This project involves 16,000 square yards of milling, 16,000 square yards of paving fabric to reduce reflective cracking, and the placement of 18,000 tons of asphalt on NE Englewood Road between N Oak and N Flora. The City also bid a new product called GlasPave25 as an alternate to paving fabric, however, only a small amount of this product has been installed locally so this product will not be used.

Superior Bowen Asphalt Co. is a company based in Kansas City, Missouri that has been in business for more than 60 years. Superior Bowen Asphalt Co. has performed numerous Mill and Overlay Programs for the City in the past. Staff is very pleased with their work and is looking forward to working with them again this year.

This work will commence following the completion of KCMO water main improvements and the City's subsequent curb and gutter replacement project awarded to Lan-Tel Communications Services Resolution No. R-15-11.

Based on all available information, staff is recommending that this project be awarded to Superior Bowen Asphalt Company at the base bid price of \$266,526.00 at the next regularly scheduled City Council meeting. Funds for this project are provided for from Special Road District and budgeted in the TST fund.
