WHEREAS, three proposals were received for the Mill Creek Bank Stabilization - Phase 1, and the proposal of Shedigs It, LLC, in the amount of \$460,591.50 has been determined by the Director of Public Works and City Engineer to be the lowest and best proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

THAT, the City Manager of the City of Gladstone, Missouri, is hereby authorized to execute a contract with Shedigs It, LLC, for work as outlined in the contract for a total amount not to exceed \$460,591.50.

FURTHER, THAT funds for such purpose are authorized from the Certificates of Participation, Series 2011 and the Capital Improvements Sales Tax Fund.

Staff received the following base bids for the referenced project:

SheDigs It, LLC Linaweaver Construction Inc. \$615,340.00

\$710,166.00

\$884,659.00

Pyramid Excavation & Construction, Inc.

This project involves bank stabilization work including block retaining wall, riprap, stabilization of exposed sanitary sewer crossings, and associated work at various locations along N. Pursell Road and in the vicinity of 6106 N. Wayne which backs to N. Flora Avenue.

SheDigs It, LLC submitted the lowest base bid for the work of this project. There were also 2 bid alternates for this project. Staff has reviewed the base bid and bid alternates and selected a combination of items from that list which provides the most viable and affordable final scope of work for the project. The total adjusted bid price from SheDigs It for the selected base bid and bid alternate items is \$460,591.50.

SheDigs It, LLC is based in Independence, MO and has been in business for four years. Staff conducted a reference check of previous work SheDigs It has performed and found all respondents to be satisfied with the work they completed.

Based on all available information, staff is recommending that this project be awarded to SheDigs It, LLC, at the adjusted bid price of \$460,591.50, including selected bid alternates, at the next regularly scheduled City Council meeting.

The funds for this project are from the Certificates of Participation, Series 2011 and the Capital Improvements Sales Tax Fund.

Please note that this project addresses immediate concerns along Mill Creek, however, additional projects within the watershed are currently being evaluated as part of the Stormwater Master Plan update.
