A RESOLUTION AUTHORIZING EXECUTION OF A CONTRACT WITH BLUE NILE CONTRACTORS, INCORPORATED, IN THE TOTAL AMOUNT NOT TO EXCEED \$75,087.00 FOR THE 2015 SANITARY SEWER CLEANING AND TELEVISIONING PROJECT.

WHEREAS, three proposals were received for the 2015 Sanitary Sewer Cleaning and Televisioning Project SP1589, and the proposal of Blue Nile Contractors, Incorporated, in the amount of \$75,087.00 has been determined by the Director of Public Works and City Engineer to be the lowest and best proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

THAT, the City Manager of the City of Gladstone, Missouri, is hereby authorized to execute a contract with Blue Nile Contractors, Incorporated for work as outlined in the contract for a total amount not to exceed \$75,087.00.

Ace Pipe Cleaning, Inc.	\$83,725.65
Reddi Services, Inc.	\$102,242.25

The Engineer's estimate, prepared by staff, was \$80,000.00.

This project involves the standard cleaning, root cutting, televising and recording of approximately 47,000 linear feet of small diameter sanitary sewer mains at various locations throughout the City.

Blue Nile Contractors, Inc. is based in Claycomo, Missouri and has been in business for twelve years. Staff has worked with Blue Nile Contractors in the past; staff is very pleased with their work and is looking forward to working with them again.
