The Engineer's estimate, prepared by staff, was \$433,452.00.

This project involves the placement of approximately 5,000 tons of asphalt on streets throughout the City. The contract also includes a "piggy-back" provision for the Village of Oakview and the Village of Oakwood. As in past years, the project includes an asphalt index to allow for the adjustment of asphalt unit prices due to changes in the oil market.

Superior Bowen Asphalt Co. is a company based in Kansas City, Missouri that has been in business for more than 60 years. Superior Bowen Asphalt Co. has performed the City's Mill and Overlay Programs in the past. Staff is very pleased with their work and is looking forward to working with them again this year.
