A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH VANCE BROTHERS, INCORPORATED, IN THE TOTAL AMOUNT NOT TO EXCEED \$148,235.61 FOR THE 2015 INTERMEDIATE MAINTENANCE PROGRAM.

WHEREAS, two proposals were received for the 2015 Intermediate Maintenance Program, Project TP1603, and the proposal of Vance Brothers, Incorporated, in the amount of \$148,235.61 has been determined by the Director of Public Works and City Engineer to be a fair proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

THAT, the City Manager of the City of Gladstone, Missouri, is hereby authorized to execute a contract with Vance Brothers, Incorporated, for work as outlined in the contract for a total amount not to exceed \$148,235.61.

FURTHER, THAT funds for such purpose are authorized from the Transportation Sales Tax fund.

WITNESSETH;

THAT, WHEREAS, The Owner has heretofore caused to be prepared certain Contract Documents comprising the Notice to Bidders, Instructions to Bidders, Proposal Form, Bond Forms, Contract Form, Regulations of the Contract and the Specifications and Plans for furnishing material and constructing improvements therein fully described, and the Contractor did, on the 21st day of June, 2015 file with the Owner a Proposal to furnish said materials and construct said improvements at the terms thereto fully stated and set forth; and
