SUBJECT: Broker Representation, 5615 N. Antioch Road

The City purchased the 5615 N. Antioch Road, commonly referred to as the Scola Property, in early 2014. Since that time, the City has maintained the property and has completed initial work that would prepare the site for sale.

In 2014, the City removed the retaining wall that was on the property and cleared the property of debris and buildings that were in disrepair. City staff has visited with a number of developers about the property and has encouraged developers to consider the development of the 1.7 acres of land.

In the past, the City has utilized brokers for the sale and purchase of land. City staff is recommending a listing agreement with Joanna B. Shawver be approved for brokerage services related to the sale of the property at 5615 N. Antioch Road. Ms. Shawver will be actively pursuing developers for the development of the land at 5615 N. Antioch Road with the intent of bringing a development project forward in the near future.
