Flora Park East Spillway Modifications - Change Order 2

The Flora Park East Spillway Modifications Project was awarded to Linaweaver Construction Incorporated by Resolution 16-64. The project included raising the existing detention basin berm and rehabilitating an existing 48" culvert. Change Order 1 addressed changes that resulted from the difference between estimated quantities and field installed quantities. This work is complete.

Change Order 2 revises the scope of work to include the rehabilitation of 3 existing culverts at NW 68th Street and N. Broadway to address issues identified by the Missouri Department of Transportation (MoDOT). MoDOT performs both bridge and large culvert inspections every 3years as a courtesy to the City. MoDOT's most recent inspection of these culverts noted several issues and recommended that the City begin planning to replace them.

The City hired Wilson and Company to complete a field inspection of the culverts, identify interim rehabilitation measures, and to develop a cost estimate for replacement. The estimated cost to replace these three culverts is approximately \$600,000.

Rehabilitation measures recommended by Wilson and Company include paving the bottom of the existing culverts with concrete, filling any voids around the culverts with grout, and the placement of riprap to reduce erosion of the creek bottom. The City has successfully used these rehabilitation techniques at other locations which can extend the life of culverts by 10 years or more. These measures will allow the City time to begin planning for the eventual replacement of these culverts, perhaps as part of the 68th Street Parkway project from N. Broadway to N. Oak.

Staff is recommending that Change Order 2 be added to the existing contract with Linaweaver Construction, Inc. at a cost of \$55,400.00 to complete rehabilitation of the 3 existing culverts. Funds are provided from the Capital Improvement Sales Tax Fund.
