A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH McCONNELL AND ASSOCIATES CORPORATION, IN THE TOTAL AMOUNT NOT TO EXCEED \$421,248.34 FOR THE NORTH CAMPBELL STREET IMPROVEMENTS - NORTHEAST 70th TERRACE TO NORTHEAST 72nd STREET PROJECT TP1708.

WHEREAS, seven proposals were received for the North Campbell Street Improvements – Northeast 70th Terrace to Northeast 72nd Street Project TP1708, and the proposal of McConnell and Associates Corporation in the amount of \$421,248.34 has been determined by the Director of Public Works and City Engineer to be the lowest and best proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

THAT, the City Manager of the City of Gladstone, Missouri, is hereby authorized to execute a contract with McConnell and Associates Corporation for work as outlined in the contract for a total amount not to exceed \$421,248.34.

FURTHER, THAT funds for such purpose are authorized from the Transportation Sales Tax Fund, Special Road District Funds, and the Combined Water and Sanitary Sewerage Fund.

Staff received the following bids for the referenced project, including Bid Alternate 1:

The Engineer's estimate, prepared by staff, was \$422,082.00.

The project base bid includes the reconstruction of approximately 950 linear feet of roadway including new curb and gutters, sidewalks, stormwater improvements, and the construction of 20 vehicle parking lot in the vicinity of NE 70th Street and N. Locust. Bid Alternate 1 includes the replacement of the water main under N. Campbell Street in the vicinity of the roadway improvements.

McConnell & Associates Corp. is a company based in North Kansas City, Missouri that has been in business for more than 50 years. Staff has worked with McConnell & Associates on various projects in the past and is looking forward to working with them again on this project.

Based on all available information, staff is recommending that this project be awarded to McConnell & Associates at the bid price of \$421,248.34, including Bid Alternate 1 at the next regularly scheduled City Council meeting. The funds for this project are available from the Transportation Sales Tax Fund, Special Road District Funds, and the CWSS Fund.

THIRD--This Contract is executed in quintuplicate, with distribution as specified in the Regulations of the Contract.
