2016 Curb, Gutter and Sidewalk Program - Change Order 6

The 2016 Curb, Gutter and Sidewalk Program was awarded to Lan-Tel Communications Services, Inc. by Resolution R-16-31. Change Order 1 was approved by Resolution R-16-45 and modified the scope of work to include sidewalks and pedestrian improvements in the downtown area and construction of a new sidewalk on NE 76th Street. Change Order 4, approved by Resolution R-17-06 added curb, gutter and sidewalk improvements in preparation for street resurfacing funded by the Gladstone Special Road District, and the installation of audible pedestrian signals at the intersection of N. Oak and NE 64th Street. Change Orders 2, 3 and 5 adjusted the contract amount to match field measured quantities.

Change Order 6 adds additional concrete work to the 2017 street maintenance program including approximately 500 linear feet of new sidewalk on NE 59th Terrace between NE 59th Street and NE Brooktree Lane (to connect the Rock Creek Greenway to sidewalk improvements made by Curry Investment Company), and the installation of approximately 300 linear feet of new curb on NE Walnut at NE 72nd Street.

Staff is recommending that Change Order 6 be added to the existing contract with Lan-Tel Communications Services, Inc. at a cost of \$51,700.00. Funds are provided from the Transportation Sales Tax Fund.
