A RESOLUTION AUTHORIZING EXECUTION OF A CONTRACT WITH LITTLE JOE'S ASPHALT, INCORPORATED, IN THE TOTAL AMOUNT NOT TO EXCEED \$387,750.51 FOR THE 2017 MILL AND OVERLAY PROGRAM; PROJECT TP1806.


WHEREAS, three proposals were received for the 2017 Mill and Overlay Program, and the proposal of Little Joe's Asphalt, Incorporated, in the amount of \$387,750.51 has been determined by the Director of Public Works and City Engineer to be the lowest and best proposal; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

THAT, the City Manager of the City of Gladstone, Missouri, is hereby authorized to execute a contract with Little Joe's Asphalt, Incorporated, for work as outlined in the contract for a total amount not to exceed \$387,750.51.


FURTHER, THAT funds for such purpose are authorized from the Transportation Sales Tax fund.

Staff received the following bids for the referenced project:

Little Joe's Asphalt, Inc.	\$387,750.51
Superior Bowen Asphalt Company	\$399,505.85
Metro Asphalt, Inc	\$409,503.45

The Engineer's estimate, prepared by staff, was \$401,384.00.

This project involves the placement of approximately 3,000 tons of asphalt on streets throughout the City. The contract also includes a "piggy-back" provision for the Village of Oakview and the Village of Oakwood. As in past years, the project includes an asphalt index to allow for the adjustment of asphalt unit prices due to changes in the oil market

Little Joe's Asphalt is a company based in Bonner Springs, Kansas that has been in business for more than 29 years. Staff has worked with Little Joe's Asphalt on various projects in the past, is very pleased with their work and is looking forward to working with them again on this project.

Based on all available information, staff is recommending that this project be awarded to Little Joe's Asphalt, Inc. at the bid price of \$387,750.51 at the next regularly scheduled City Council meeting. The funds for this project are available from the Transportation Sales Tax fund.

WITNESSETH;

THAT, WHEREAS, The Owner has heretofore caused to be prepared certain Contract Documents comprising the Notice to Bidders, Instructions to Bidders, Proposal Form, Bond Forms, Contract Form, Regulations of the Contract and the Specifications and Plans for furnishing material and constructing improvements therein fully described, and the Contractor did, on the 18th day of July, 2017, file with the Owner a Proposal to furnish said materials and construct said improvements at the terms thereto fully stated and set forth; and
