NE 58th Terrace washed out during the heavy rains in late July which required the immediate closure of the street. Consequently, staff requested a bid from Linaweaver Construction, Incorporated to complete the repair which included the installation of two 60 inch pipes to replace the existing 48 inch pipe that failed. The City was also able to address some bank stabilization issues with riprap just north of the project per the request of residents in the area.

Linaweaver Construction is currently under contract with the City on other projects. Linaweaver Construction's bid was considered to be fair and allowed the City to expedite completion of the work. The project is now complete and the street is open to traffic.
