A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH BLUE NILE CONTRACTORS, INCORPORATED, IN THE TOTAL AMOUNT NOT TO EXCEED \$80,040.00 FOR THE 2017 SANITARY SEWER CLEANING AND TELEVISIONING PROJECT SP1889.

WHEREAS, three proposals were received for the 2017 Sanitary Sewer Cleaning and Televisioning Project SP1889, and the proposal of Blue Nile Contractors, Incorporated, in the amount of \$80,040.00 has been determined by the Director of Public Works and City Engineer to be the lowest and best proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLADSTONE, MISSOURI, AS FOLLOWS:

THAT, the City Manager of the City of Gladstone, Missouri, is hereby authorized to execute a contract with Blue Nile Contractors, Incorporated for work as outlined in the contract for a total amount not to exceed \$80,040.00.

FURTHER, THAT, funds for such purpose are authorized from the Combined Waterworks and Sewerage System Funds Budget.

Staff received the following bids for the referenced project:

Blue Nile Contractors, Inc.	\$80,040.00
Ace Pipe Cleaning, Inc.	\$95,628.00
Hydro-Klean, LLC	\$101,950.50

The Engineer's estimate, prepared by staff, was \$95,779.00.

This project involves the standard cleaning, root cutting, televising and recording of approximately 54,000 linear feet of small diameter sanitary sewer at various locations throughout the City.

Blue Nile Contractors, Inc. is based in Claycomo, Missouri and has been in business for fourteen years. Staff has worked with Blue Nile Contractors in the past; staff is very pleased with their work and is looking forward to working with them again.

Based on all available information, staff is recommending that Project SP1889 be awarded to Blue Nile Contractors, Inc. at a total price of \$80,040.00 at the next regularly scheduled City Council meeting. Funds are provided from the CWSS Fund.
