<u>Subject:</u> Final Payment, Emergency Repair and Replacement of the 20 inch Transmission Main at North Broadway and Northwest Englewood Road, Project WP2391.

Background: Work has been completed on the referenced project and the contractor, Kissick Construction Company, has made application for final pay. The Change Order was the result of extending the new 24" pipe an additional 40-feet to the south to replace a section of existing pipe that was repaired with a clamp in 2009 and to cross over the top of KCMO's existing 48" transmission main that was installed in 2017. The final project included the installation of approximately 290-feet of 24" C900 PVC water main at an average depth of 6-feet, a new air release valve, two (2) 24" butterfly valves, and street restoration.

<u>Budget Discussion</u>: Funds for this emergency project were made available by deferring the purchase of a Public Works dump truck, ARPA, and CWSS fund balance. Due to the size of the project, a year-end budget amendment may be required.
