FURTHER, THAT, funds for such purpose are authorized from the Combined Waterworks and Sewerage System Fund and Capital Improvement Sales Tax Fund.

Subject: Contract Award, FY24 Water Main Replacements and Storm Drainage, Project WP2487

<u>Background</u>: Seven bids were received for this project. Infrastructure-Solutions, LLC was the low bidder with a bid of \$968,040.00 including Bid Alternate A. This project includes the installation of 4,300 LF of 8" water main, 100 LF of 24" storm pipe in the vicinity of 2312 NE 75th Terrace, and the rehabilitation of approximately 500 LF of 42" and 48" storm pipe on NE Brooktree Lane that is failing.

<u>Budget Discussion</u>: Funds are available in the amount of \$ 1,200,000.00 from the CWSS fund and CIST fund. Ongoing costs are estimated to be \$1,000,000 annually. Previous years' funding was \$1,600,000.00.

<u>Public/Board/Staff Input:</u> City staff contacted references for Infrastructure-Solutions, LLC and all were positive. Staff recommends awarding this project, including bid alternate A, to Infrastructure-Solutions, LLC. Furthermore, the completion of work in the vicinity of 2312 NE 75th Terrace is contingent upon the property owner's execution of a letter agreement prepared with the assistance of the City Attorney that clearly defines the work to be performed by the City.
