WHEREAS, the Commissioners of Gladstone Special Road District No. 3 have determined that it is in the best interests of the residents of the District to provide funding for needed road improvements during Fiscal Year 2015.

THAT, the Commissioners of Gladstone Special Road District No. 3 hereby approve the expenditure of funds in the amount of \$395,000.00 from Gladstone Special Road District No. 3 funds for road improvements commonly referred to as The Northeast Englewood Road Project.

FURTHER, THAT the Commissioners of Gladstone Special Road District No. 3 authorize the transfer of funds to the City of Gladstone, Missouri, in an amount equal to 15% of the total annual revenues received by the Road District in fiscal year 2014 and 2015 to be used by the City of Gladstone for related administrative services; and

FURTHER THAT such funds shall be transferred to the City of Gladstone for such purposes.
