**Thursday, October 17**

Today you will travel to **Hannibal, Missouri** and visit the Mark Twain Boyhood Home, Becky Thatcher's House, Huckleberry Finn House, J.M. Clemens Justice of the Peace Office, Grant's Drugstore, Interpretive Center, and the Museum Gallery. You will also discover a treasure trove of original paintings by the iconic Norman Rockwell. This afternoon you will travel to the **Quad Cities**. Located on the Mississippi River, the region encompasses five cities: Davenport, Iowa, Bettendorf, Iowa, Moline, Illinois, East Moline, Illinois, and Rock Island, Illinois. Your hotel for the next two nights is the **Bally Casino Resort**. (Lunch is included today).

**Friday, October 18**

This morning you will visit the **Mississippi River Visitor Center**, nestled on Rock Island Arsenal Island. This center provides a unique opportunity to observe navigation through the Lock & Dam system at Lock & Dam 15, where you'll have one of the best views of vessels locking through the Upper Mississippi River. Next you will board the **Celebration Belle Riverboat** for a four-hour Fall Foliage Lunch Cruise, where the mighty Mississippi River showcases its autumn splendor. You will experience the fascinating process of locking through Lock & Dam 14 and enjoy a delicious lunch all while listening to live music spanning from the 1940s to the present. Next you will visit the **John Deere Pavilion** where you'll get up close to vintage machines and engage with interactive exhibits that highlight the connection between John Deere's past and its future. Tonight, you have reserved seats at **Circa '21 Dinner Theatre** where you'll enjoy a delicious dinner, a performing waitstaff, and an enjoyable theatre production all in a historic 1921 venue! With its blend of theater magic and delectable cuisine, Circa '21 promises an unforgettable evening to end our time in the Quad Cities. (Breakfast, lunch and dinner are included today).

**Saturday, October 19**

This morning you will travel to the **Amana Colonies** where you'll step into a world of authentic German ambiance. These seven scenic villages have a rich history rooted in communal living that flourished for over 90 years. The history of the Amana Colonies, a National Historic Landmark and one of America's longest-lived communal societies, begins in 1714 in the villages of Germany and continues today on the Iowa prairie. You will be joined by a step on guide and learn the history of the colonies, and you'll enjoy a delicious family style meal at the Ox Yoke Inn. Later you'll return to Gladstone with great memories and new friends. (Breakfast and lunch are included today).
